**Sub: Payments of Grant to the Municipalities/ Urban Local Bodies in K.M.D. Area in lieu of taxes realised on Trades, professions and callings during 2011 - 12 (1<sup>st</sup> instalment)**

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 60,00,000/- (Rupees sixty lakh) only as grant in lieu of taxes realised on Trades, professions and callings to the Urban Local Bodies within K.M.D. Area as per enclosed statement for the year 2011-2012 (1st instalment).

2. The fund sanctioned above will be drawn by the concerned District Magistrate who will disburse the amounts to the Urban Local Bodies in his jurisdiction by transfer credit through L.F.A/C of the concerned Urban Local Bodies.

3. The charge is debit to the head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj-Institutions-00-200-Other Miscellaneous Compensation & Assignment-NP-Non Plan-023-Grants-in-Aid to the Municipalities/ Urban Local Bodies in K.M.D. Area in lieu of taxes realised on Trades, professions and callings-31-Grants-in-Aid-GENERAL-02-other grants-V" under Demand No.39/MA in the current year's vote-on-account budget i.e. 2011-2012.

4. The Grants-in-Aid sanction in para 1 above is a general purpose grant which is released to the Urban Local Bodies for taking up various maintenance works like repair of roads, riverfront beautification, improvement of footpath, illumination of important places, works for parks and squares etc.

5. Utilisation Certificate is to be furnished by Kolkata Municipal Corporation in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, to the Principal AG (A&E), West Bengal.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 along with Memo No. 700-FB dated 31.03.2011.
