Sub : Release of Fixed Grant to the Municipal Corporation and other Urban Local Bodies (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) during the year 2009-10 for the month of August, 2009 (5th instalment) with arrear, if any.

The undersigned is directed, by order of the Governor to say that the Governor is pleased to sanction and release for payment on ad-hoc basis to the Municipal Corporations and other Urban Local Bodies, a sum of Rs.4,74,66,694/- (Rupees Four crore seventy four lakh sixty six thousand six hundred and ninety four) only as per enclosed statement as Fixed Grant (5th instalment) for the month of August, 2009 during the year 2009-10 with arrear, if any.


2. The District Magistrate is hereby authorised to draw the amount sanctioned above and disburse the same by transfer credit through the Local Fund Account of the respective Urban Local Bodies. Only for Dankuni Municipality in Hooghly, the Chairman of the Board of Administrator shall act as the DDO.

3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions - 00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations & Other Urban Local Bodies-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the current year's Vote-on-Account budget i.e. 2009-2010.

4. The Grants-in-aid sanctioned above is for general purpose (Salary or Non-Salary) Grants, Utilisation certificate is to be furnished by the Municipalities and other Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I. Submission of Utilisation Certificate upto June, 2009 is required for further release of fund.

5. This order issues in exercise of the powers delegated under Finance Department Memo.No.900-FB dated 27.07.2009.

6. The Principal Accountant General(A&E), West Bengal and others concerned are being informed.


