Sub: Allotment of Fixed Grant to the Notified Area Authorities towards salaries of their employees for the month of September, 2011 with arrear if any.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs. 10,86,736/- (Rupees ten lakh eighty-six thousand seven hundred and thirty-six) only to the Notified Area Authorities as stated against each in the enclosed statement the grant towards salaries for September, 2011 of their regular employees whose appointment had been approved by the State Government alongwith such contractual person reengaged by the ULBs in accordance with G.O. No. 114/MA/O/C-9/2A-13/2010 dated 25.02.2011 and the communication on the same has been received from ULBs to the administrative department till date.

2. The District Magistrate concerned is hereby authorised to draw the amount sanctioned hereinabove and disburse the same to the concerned Urban Local Bodies by transfer credit through the Local fund Account of the concerned Urban Local Bodies only.

3. Any over payment or under payment in this regard against revised Basic Pay as per ROPA-2009 will be adjusted from the grants to be released for this purpose later except for these persons mentioned in G.O. No. 114/MA/O/C-9/2A-13/2010 dated 25.02.2011 who will be provided as contractual remuneration.

4. The charge is debitible to the head, "2217-Urban Development-05-Other Urban Development Schemes-193-Assistance to Nagar Panchayats/Notified Area committees or equivalent thereof-NP-Non-Plan-006-Fixed Grants to the Notified Authorities towards Salaries of their employees-31-Grants-in-aid-GENERAL-01-Salary Grants-V" under Demand No.39/MA in the current year's vote-on-account budget i.e. 2011-2012.

5. The Utilisation Certificate in respect of the grant to be drawn by the Local Body should be submitted in the prescribed form in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, direct to the Principal Accountant General (A&E), West Bengal, Volume-I, direct to the Principal Accountant General (A&E), West Bengal with a copy to the undersigned, as soon as the amount is drawn & utilised.

6. Utilisation Certificate upto August, 2011 shall be furnished by the concerned Urban Local Bodies failing which further allotment will remain withheld.

7. The Principal Accountant General (A&E), West Bengal / Treasury Officer and other concerned are being informed.

8. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 along with memo no. 700 – FB dated 31.03.2011.
