The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release of a sum of Rs.15,92,509/- (Rupees fifteen lakh ninety two thousand five hundred and nine) only as to the Kulti/Bongaon/English Bazar Municipality as grant for payment of Dearness Allowance @ 35% for the month of August, 2008 as per revised staff statistics.

2. The Grants-in-aid sanctioned herein above will be drawn by the concerned District Magistrates Burdwan/North 24-Parganas/Malda who will deposit the same in his P.L. A/c. and will then disburse as dearness Allowance to the existing regular employees of Kulti/Bongaon/English Bazar Municipality against sanctioned strength from his end under jurisdiction.

The charge is debitible to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-020-Dearness Concession to the Employees of Municipal Corporation and Other urban Local Bodies in K.M.D.A & Non-K.M.D.A, Area-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA in the current year's Budget (2008-2009).

4. The Utilisation Certificate in respect of the grant to be drawn by the Kulti/Bongaon/English Bazar Municipality should be furnished in the prescribed form direct to the Principal Accountant General(A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto July, 2008 will be required to release further grants in this regard.
