**Sub: Release of Fixed Grant to the Municipal Corporation and other Urban Local Bodies (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) during 2011-2012 for the month of September, 2011 (6<sup>th</sup> instalment) with arrear if any.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment on ad-hoc basis to the Municipal Corporation and other Urban Local Bodies (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) a sum of **Rs. 9,16,21,526/- (Rupees nine crore sixteen lakh twenty-one thousand five hundred and twenty-six)** only as per enclosed statement as Fixed Grant (6<sup>th</sup> instalment) for the month of **September, 2011** during the year 2011-2012 with arrear, if any.

2. The District Magistrate is hereby authorised to draw the amount sanctioned above and disburse the same by transfer credit through Local fund Account of the respective Urban Local Bodies.

3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations and other Urban Local Bodies - 31-Grants-in-Aid-GENERAL-02-Other Grants-V" under Demand No. 39/MA in the current year's vote-on-account budget i.e. 2011-2012.

4. The Grants-in-aid sanctioned above, Utilisation Certificate is to be furnished by the Municipal Corporation and other Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I direct to the Principal Accountant General (A&E), West Bengal with a copy to this Department, as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto **August, 2011** is required for further release of fund.

5. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.

6. This order issues in exercise of the power delegated under Finance Department's memo no. 1530-FB dated 29.07.2011 alongwith memo no. 700 – FB dated 31.03.2011.
