Sub : Payment of Grant to the Municipal Corporation and other Urban Local Bodies for Dearness Allowance to their employees for the month of August, 2009 with arrears, if any on revised basic pay as per ROPA, 2009 on provisional basis.

The undersigned is directed by order of the Governor, to say that the Governor is pleased to sanction and release a sum of Rs.3,39,31,579/- (Rupees Three Crore thirty nine lakh thirty one thousand five hundred and seventy nine) only to the Urban Local Bodies as stated against each in the enclosed statement as grants for payment of Dearness Allowance to their employees for the month of August, 2009 on revised basic pay as per ROPA, 2009 .


2. The Grants-in-aid sanctioned herein above will be drawn by the concerned District Magistrate and will disburse the same to the Urban Local Bodies in his jurisdiction by transfer credit through Local Fund Account to the concerned Urban Local Bodies. The Chairman of the Board of Administrators shall act as D.D.O. in Dankuni Municipality, District Hooghly.

3. The charge is debitable to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-020-Dearness Concession to the employees of Municipal Corporation and Other Local Bodies in K.M.D.A. & Non-K.M.D.A., Areas-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA" in the current year's (2009-2010). The excess or shortfall against revised basic pay as per ROPA, 2009 will be adjusted in due course.

4. The Utilisation Certificate in respect of the grants to be drawn by the Kolkata Municipal Corporation and other Urban Local Bodies should be furnished in the prescribed form in terms of Note 2 below SR 330A of the Treasury Rules, W.B. Vol-I direct to the Principal Accountant General(A&E), West Bengal, with a copy to this Department as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto July, 2009 must be necessary for release of further fund.

5. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.


