Sub : Release of Fixed Grant to the Municipal Corporation and Other Urban Local Bodies (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) during the Year 2008-2009 for the month of August, 2008 (5th instalment) with arrear, if any.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment on ad-hoc basis to the Municipal Corporations and other Urban Local Bodies a sum of Rs.10,08,92,500/- (Rupees Ten Crore eight Lakh ninety two thousand and five hundred) only as per enclosed statement as Fixed Grant (5th instalment) for the month of August, 2008 during the year 2008-2009, with arrear, if any.

2. The District Magistrate is hereby authorised to draw the amount sanctioned above and disburse the same by transfer credit through the Local Fund Account of the respective Urban Local Bodies.
3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations and Other Urban Local Bodies-31-Grants-in-Aid-02-Other Grants-V" under Demand No.39/MA in the current year's budget (2008-2009).
4. The Grants-in-aid sanctioned above is for general purpose (Salary or Non-Salary) grants, Utilisation Certificate is to be furnished by the Municipalities and other Urban Local Bodies in terms of Note-2 below SR-330A of the Treasury Rules, West Bengal, Volume-I. Submission of Utilisation Certificate upto July, 2008 is required for further release of fund.
5. This order issues in exercise of the powers delegated under Finance Department Memo No.850-FB dt.31.07.2008.
6. The Principal Accountant General (A&E), West Bengal and others are being informed.
