Sub: Payment of grants to the Urban Local Bodies on Account of 'Pension' for the Municipal Pensioners at the revised rate during the year 2011-2012.

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 1,41,47,186/- (Rupees one crore forty-one lakh forty-seven thousand one hundred and eighty-six) only to the Urban Local Bodies on adhoc basis towards part payment of 40% of total requirement (Basic Pension + Dearness Relief) of pension on the revised scale of pay to the pensioners of the Urban Local Bodies for the year 2009-10 alongwith Relief-on-Pension upto 2008-09 as per enclosed statement during this financial year i.e. 2011-12.

2. The District Magistrate concerned is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through Local Fund Account of the concerned Urban Local Bodies in favour of the pensioners who have received the P.P.O. for drawal of their pension.

3. The charge is debitible to the head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension of Employees of Local Bodies-04-Pension/Gratuities-V" under Demand No. 18/Finance (Audit) in the current year's Vote-on-Account budget i.e. 2011-2012.

4. Utilization Certificate is to be furnished by the Howrah Municipal Corporation in the prescribed form directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilized.

5. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 along with memo no. 700 – FB dated 31.03.2011.

6. The Principal Accountant General (A&E), West Bengal and the Kolkata Pay & Accounts Office II are being informed.
