Sub : **Release of grants to the Kolkata Municipal Corporation on account of 'Pension' to the Municipal Pensioners during 2011 - 2012**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs. 23,10,61,723/- (Rupees twenty three crore ten lakh sixty one thousand seven hundred twenty three) only to the Kolkata Municipal Corporation as grants on adhoc basis towards part payment of 40% of total requirement (Basic Pension + Dearness Relief) of pension on the revised scale of pay to the pensioners of Kolkata Municipal Corporation as communicated vide their letter no. Con/Com/47/2011-2012 dated 12.05.2011 for the year 2009 - 10, during this financial year i.e. 2011 - 12.

2. The Grants-in-aid sanctioned herein above will be drawn by the Municipal Commissioner, Kolkata Municipal Corporation in T.R. Form No. 31 and also disbursed by him. He will also act as DDO for drawal of Grants-in-aid Bills including transfer credit bills in respect of Local fund Account and the Controller of Municipal Finance & Accounts (CMFA) will act as the operator of Local fund Account for signing LF Cheque from Kolkata Pay & Accounts Office II.

3. The charge will be debitible to the head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001- Provision for payment of pension of Employees of Local Bodies-04-Pension/Gratuities-V" under Demand No. 18/Finance (Audit) in the current year's Vote-on-Account budget i.e. 2011-2012.

4. Utilization Certificate is to be furnished by the Kolkata Municipal Corporation in the prescribed form directly to the Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilized.

5. This order issues in exercise of the power delegated under Finance Department Memo No. 700-FB dated 31.03.2010

6. The Principal Accountant General (A & E), West Bengal and the Kolkata Pay & Accounts Office II are being informed.
