The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release a sum Rs.10,92,047/- (Rupees Ten lakh ninety two thousand and forty seven) only to the Kulti, Bongaon and English Bazar Municipality as grant for payment of Dearness Allowance for the month of April,2009 as per revised staff statistics on ad-hoc basis.

The Grants-in-aid sanctioned herein above will be drawn by the District Magistrate, Burdwan/North 24-Parganas/Malda who will deposit the same in his P.L.A/c. and will then disburse Dearness Allowance to the existing regular employees of the Kulti/Bongaon/English Bazar Municipality against sanctioned strength from his end under his jurisdiction.

The charge is debitible to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-020-Dearness Concession to the Employees of Municipal Corporation and other Urban Local Bodies in K.M.D.A. & Non-K.M.D.A. Areas-31-Grants-in-Aid-01-Salary Grants-V" under Demand No.39/MA in the current year's budget i.e. 2009-2010. Any excess or shortfall against revised basic pay as per ROPA-2009 will be adjusted in due course.

4. The Utilisation Certificate in respect of the grants to be drawn by the Kulti/Bongaon/English Bazar Municipality should be furnished in the prescribed form direct to the Principal Accountant General(A&E), West Bengal with a copy to this Department as soon as the amount is drawn and utilised. Submission of Utilisation Certificate upto March,2009 will be required to release further grants in this regard.
