Sub: Payment of grants to the Urban Local Bodies on Account of 'Pension' for the Municipal Pensioners at the revised rate during the year 2012-2013.

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction an release for payment of a sum of Rs. 17,09,38,531/- (Rupees Seventeen crore nine lakh thirty eight thousand five hundred thirty one) only to the Urban Local Bodies on adhoc basis towards payment of 40% of total requirement (Basic Pension, Dearness Relief) of pension on the revised scale of pay to the pensioners of the Urban Local Bodies for the year 2009-2010, 2010-2011 and 2011-12 along with Relief-on-pension upto as specified in the 'Remarks' column of the enclosed statement during this financial year i.e. 2012-2013.

2. The District Magistrate concerned is hereby authorised to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through Local Fund Account of the concerned Urban Local Bodies in favour of the pensioners who have received the P.P.O. for drawal of their pension.

3. The charge is debitable to Code head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employee of Local Bodies-NP-Non-Plan-001-Provident" for payment of pension of Employees of Local Bodies-04-Pension/Gratuities Vth under Demand No. 18/Finance (Audit) in the current year's budget i.e. 2012-2013.

4. Utilization Certificate is to be furnished in the prescribed form directly to the Principal Accountant General (A&E) West Bengal with a copy to this Department as soon as the amount is drawn and utilized.

5. This order issues in exercise of the powers delegated under Finance Department Memo No. 800-FB dated 31.07.2012.

6. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
