Sub: Release of Entertainment Tax to Howrah Municipal Corporation during 2011-12.(2nd instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction the payment Rs. 49,80,000/- (Rupees forty-nine lakh eighty thousand) only to the Howrah Municipal Corporation as grants on account of Entertainment Tax during the year 2011-2012 (2nd instalment).

2. The fund sanctioned above will be drawn by the Commissioner, Howrah Municipal Corporation in T.R. Form No. 31, after it is duly countersigned by District Magistrate, Howrah.

3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporations and other Local Bodies - 31-Grants-in-Aid-GENERAL-02-Other Grants-V" (MA) under Demand No. 39/MA in the current year's vote-on-account budget i.e. 2011-2012.

4. The Grants-in-aid sanctioned in para 1 above is for general-purpose/Non Salary grant which is released to the Urban Local Body for payment against cost of establishment and or for liquidation after reconciliation of out standing dues of CESC/WBSEDCL, etc. on priority basis.

5. The Corporation should furnish Utilisation Certificate to the Principal Accountant General (A&E), West Bengal in prescribed form as soon as the grant is drawn and utilised.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 alongwith memo no. 700 - FB dated 31.03.2011.

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
