Nos. 459/MA/P/C-10/1G-2/2005 (FS) dated the 25<sup>th</sup> March, 2008, 481/MA/P/C-10/1G-2/2005 (FS) dated the 28<sup>th</sup> March, 2008, 482/MA/P/C-10/1G-2/2005 (FS) dated the 28<sup>th</sup> March, 2008 as the 1<sup>st</sup> and 2<sup>nd</sup> instalments of the Second State Finance Commission Award for 2007-2008 for execution of development schemes there under.**

## MEMO

The undersigned is directed to say that a sum of Rs. 46,61,850/- (Rupees forty six lakh sixty one thousand eight hundred and fifty) only which was sanctioned in favour of urban local bodies as detailed in the enclosed statement as the instalments of Second State Finance Commission Award for 2007-2008, vide this Department G.O. No. 459/MA/P/C-10/1G-2/2005 (FS) dated the 25<sup>th</sup> March, 2008, 481/MA/P/C-10/1G-2/2005 (FS) dated the 28<sup>th</sup> March, 2008, 482/MA/P/C-10/1G-2/2005 (FS) dated the 28<sup>th</sup> March, 2008 for execution of development schemes thereunder, could not be drawn by the concerned Municipalities due to some unavoidable circumstances .

2. The Municipalities have now prayed for re-allotment / revalidation of the lapsed fund from the budget allocation of the current financial year.

3. After careful consideration of the matter and in partial modification of this Department G.O. Nos. 459/MA/P/C-10/1G-2/2005 (FS) dated the 25<sup>th</sup> March, 2008, 481/MA/P/C-10/1G-2/2005 (FS) dated the 28<sup>th</sup> March, 2008, 482/MA/P/C-10/1G-2/2005 (FS) dated the 28<sup>th</sup> March, 2008, the undersigned is directed, by order of the Governor, to say that the Governor is pleased to revalidate and sanction the said amount of Rs. 46,61,850/- (Rupees forty six lakh sixty one thousand eight hundred and fifty) only in favour of Jiaganj-Azimganj, Murshidabad and Rampurhat Municipalities out of the current year's budget allocation under the Second State Finance Commission.

4. The District Magistrates concerned are hereby authorised to draw the amount sanctioned in para 3 above in T.R. Form No. 31 and disburse the same to the concerned Municipalities by transfer credit to their Local Fund Accounts with the Treasuries concerned.

5. The scheme will be executed in accordance with the N.S.D.P. Guidelines, wherever applicable.
