Sub : Payment of grants to the Urban Local Bodies on account of 'Pension' for the Municipal Pensioners at the revised rate during 2011 – 2012 (1st installment)

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for the payment of a sum of Rs. 10,92,08,303/- (Rupees Ten crore ninety two lakh eight thousand three hundred and three) only to the Urban Local Bodies on adhoc basis as per allotment in the enclosed statement as 40% of total requirement (Basic Pension + Dearness Relief) of pension to the pensioners of the Urban Local Bodies for the year 2009 – 10, during this financial year i.e. 2011 – 12.

2. The District Magistrate concerned is hereby authorized to draw the grants sanctioned above and disburse the same to the Urban Local Bodies concerned by transfer credit through Local Fund Account of the concerned Urban Local Bodies in favour of the pensioners who have received the PPO for drawal of their pension.

3. The charge will be debitable to the head, "2071-Pensions and other Retirement Benefits-01-Civil-110-Pension of Employees of Local Bodies-NP-Non-Plan-001- Provision for payment of pension of Employees of Local Bodies-04-Pension/Gratuities-V" under Demand No. 18/Finance (Audit) in the current year's Vote-on-Account budget i.e. 2011-2012.

4. Utilization Certificate is to be furnished by the Urban Local Bodies in the prescribed form direct to the Principal Accountant General (A&E), West Bengal with a copy to this Department positively, as soon as the amount is drawn and utilized.

5. This order issues in exercise of the power delegated under Finance Department Memo No. 700-FB dated 31.03.2010

6. The Principal Accountant General (A & E), West Bengal and the West Bengal/Treasury Office and other concerned are being informed.
