Subject: **Allotment of fund in favour of Arambagh Municipality for Construction of Harijans' Quarters under Development of Municipal Areas(Municipalities) Schemes.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.35,00,000/-(Rupees thirty five lakh) only in favour of Arambagh Municipality towards the partial cost for Construction of Harijans' Quarters. The balance amount is to be provided by the concerned Municipality.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.
3. Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department as well as to the State Urban Development Agency.
4. A list of the scheme undertaken showing its name, location, estimate and expenditure incurred should invariably be furnished to State Urban Development Agency.
5. The amount is debit to the Head of Account, "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities / Municipal Councils-SP-State Plan (Annual Plan and Eleventh Plan)-006-Development of Municipal Areas(Municipalities)-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No. 39/MA in the current year's budget.
