Sub : **Payment of Grants on account of Entertainment Tax to Urban
Local Bodies during the year 2009-2010 (2nd instalment).**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.8,45,66,000/- (Rupees Eight Crore forty five lakh sixty six thousand) only as grant on account of Entertainment Tax (2nd instalment) to the Urban Local Bodies as per enclosed statement for the year 2009-2010 with arrears if any.

2. The fund sanctioned above will be drawn by the concerned District Magistrates who will disburse the amounts to the Urban Local Bodies in his jurisdiction by transfer credit through Local Fund Account of the concerned Urban Local Bodies and will, impress upon the Urban Local Bodies to clear the dues to WBSEB/CESC on priority basis.

3. The charge is debitable to the Head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj Institution-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporation and other Urban Local Bodies-31-Grants-in-aid-02-Other Grants-V" (MA) under Demand No.39/MA in the current year's budget i.e. 2009-2010.

4. The grants-in-aid sanctioned in para 1 above is for general purpose/non-Salary grant and shall be utilised for payment of dues of WBSEB/CESC/HUDCO etc. on priority basis and for payment against cost of establishment after clearing the dues of aforesaid agencies in full.

5. The undersigned is further directed to request the Urban Local Bodies for confirmation of actual outstanding dues of CESC/WBSEB/HUDCO etc. if any, after payment of the amount sanctioned in this Government Order and also to indicate the programme of the Urban Local Bodies to clear their outstanding dues in future at an early date, in the event of failure the Government will have no other alternative but to deduct their amount from the next allotments to meet up the outstanding dues, if any.

6. The Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal, to the Principal Accountant General(A&E), West Bengal.

7. This order issues in exercise of the power delegated under Finance Deptt's Memo No.900-FB dated 27.07.2009.

8. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
