The undersigned is directed to say that a sum of Rs.10,75,924/- (Rupees ten lakh seventy five thousand nine hundred and twenty four) only which was sanctioned in favour of Jiaganj-Azimganj Municipality, vide this Department G.O.No.450/MA/P/C-10/1G-22/05 Pt.(FS) dated the 17th March,2008 for Development/Construction of Children Park under Development of Municipal Areas (SCSP) Scheme, could not be drawn by the concerned Municipality due to some unavoidable circumstances.

2. The Municipality has now prayed for re-allotment/revalidation of the lapsed fund from the budget allocation of the current financial year.

3. After careful consideration of the matter, the undersigned is directed by order of the Governor to say that the Governor is pleased to revalidate and sanction the said amount of Rs.10,75,924/- (Rupees ten lakh seventy five thousand nine hundred and twenty four) only in favour of Jiaganj-Azimganj Municipality out of the current year's budget allocation under Development of Municipal Areas (SCSP) scheme.

4. The District Magistrate concerned is authorized to draw the amount sanctioned in para-3 above in T.R. Form No.31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.

5. The Utilisation Certificate in terms of S.R.330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department as well as to the State Urban Development Agency.

6. A statement of estimate and expenditure incurred should invariably be furnished to State Urban Development Agency.

7. The amount is debit to the Head of Account "2217-Urban Development-05-Other Urban Development schemes-789-Special Component Plan for SC-SP-State Plan (Annual Plan and Eleventh Plan) - 001-Development of Municipal Areas-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No.39/MA in the current year's budget.

8. This order issues with the concurrence of the Finance Department vide their U.O. No. Group 'R' 126 dated 29.08.2008.


9. The Principal Accountant General (A&E), West Bengal and all other concerned are being informed.
