

Sub : Allotment of fund in favour of Jalpaiguri Municipality for Construction of Sweepers' Quarters under Development of Municipal Areas(SCSP) Scheme.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.25,00,000/- (Rupees Twenty five lakh) only in favour of Jalpaiguri Municipality towards the partial cost of Construction of Sweepers' Quarters under Development of Municipal Areas (SCSP) Scheme. The balance amount is to be borne by the Municipality.

2. The District Magistrate concerned is authorized to draw the amount sanctioned in para 1 above in T.R. Form No.31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.
3. Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department as well as to the State Urban Development Agency.
4. A statement of estimate and expenditure incurred should invariably be furnished to State Urban Development Agency.
5. The amount is debit to the Head of Account "2217-Urban Development-05-Other Urban Development Schemes-789-Special Component Plan for SC-SP-State Plan (Annual Plan and Eleventh Plan)-001-Development of Municipal Areas-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No.39/MA in the current year's budget.
6. This order issues in exercise of the power delegated under Finance Department Memo. No.850-FB dated 31.07.2008.
7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.
