Subject: **Release of Grant-in-aid for implementation of Integrated Low Cost Sanitation Scheme (ILCS) as per Revised Guidelines (Central Share) for 2011 – 2012 – 1<sup>st</sup> instalment.**

## MEMO

The undersigned is directed, by order of the Governor, to say that the Governor has been pleased to sanction payment of a sum of Rs. 1,47,75,340/- (Rupees one crore forty seven lakh seventy five thousand three hundred forty) only being the first instalment of the Central Share, to the State Urban Development Agency for implementation of the Integrated Low Cost Sanitation Scheme (ILCS) in the Urban Local Bodies as per revised guidelines, the schemes for which are already approved by the Central Coordination Committee of the Government of India. The amount now sanctioned in three parts is the 25% of total subsidy approved in the 11<sup>th</sup> Central Co-ordination Committee meeting held on 23.06.2011.

2. A sum of Rs. 1,47,75,340/- (Rupees one crore forty seven lakh seventy five thousand three hundred forty) only is accordingly allotted hereby to meet the expenditure towards the purpose mentioned above.

3. He is hereby requested to issue an Account Payee Treasury Cheque for the amount sanctioned in para-1 above in favour of the State Urban Development Agency, enabling the latter to deposit the said amount to its dedicated Bank Account maintained by it for the purpose, as per specific instructions of the Government of India.

4. The Grants-in-aid sanctioned above may be drawn by the Director, State Urban Development Agency in T.R. Form No.31 after it is duly countersigned by the sanctioning authority. The amount so drawn will be released by State Urban Development Agency in favour of the concerned Urban Local Bodies, after following the due process for assessing the requirements of the latter.

5. The Utilization Certificates are required to be furnished by the Urban Local Bodies for the amount sanctioned in terms of Note-2 below S.R. 330A of the Treasury Rules, W.B., Vol-I, duly accompanied by the physical and financial progress report in the prescribed format to the appropriate authorities.

6. The charge is debitable to the head "2215-Water Supply and Sanitation-02-Sewerage & Sanitation-789-Special Component Plan for Scheduled Castes-CS-Centrally Sponsored (New Schemes) -001-Programme for Liberation of Scavengers by conversion of Privies into Sanitary Latrines in Municipal Towns-31-Grants-in-aid-GENERAL-02-Other Grants-V-Voted" in the current year's vote-on-account budget provision under Demand No. 39/MA.

7. This order issues with the concurrence of the Finance Department vide their U.O. No. Gr. 'N' 0987 dated 15.09.2011.
