

But the said amount could not be drawn by the ULB during the concerned financial year 2014-2015. Upon submission of non-drawal certificate of Rs. 1,31,46,500/- from the Treasury Officer, Chandernagore, revalidation of Rs. 1,31,46,500/- is made during the current financial year 2016-2017.
