Sub: **Grants for payment of arrear in respect of the employees of Municipal Corporations and other urban Local Bodies (excluding Kolkata M.C. & Howrah M.C.) in revised scale of pay as per ROPA 2009 (3<sup>rd</sup> instalment in 2011-2012).**

In continuation of G.O. No. 102G(2)/MA/N/C-2/1G-12/2009 dated 11.08.2010 the undersigned is directed by order of the Governor to say that the Governor is pleased to sanctioned and release **Rs. 10,99,88,602/- (Rupees ten crore ninety-nine lakh eighty-eight thousand six hundred and two)** Only on ad-hoc basis (the basis being the estimate furnished by DLB, WB) towards 50% of (93 per cent of one-third of total requirement) as the third instalment of arrear of pay and allowances for the period from 01.04.2008 to 31.03.2009 due to revision of pay and allowances as per recommendation of 5<sup>th</sup> Pay Commission in respect of the employees of Municipal Corporations and other Urban Local Bodies (excluding Kolkata M.C. & Howrah M.C.) in accordance with Para II of Resolution No. 137/MA/O/C-5/CC/1R-1/2009 dated 27.02.2009 and 79/MA/O/C-9/2P-5/2009 dated 27.02.2009 during the financial year 2009-2010.

2. The amount sanctioned in para-I above is to be monitored and sub-allotted from the level of Director of Local Bodies, West Bengal in favour of the Urban Local Bodies and the District Magistrate of the concerned district will act as the Drawing & Disbursing Officer for drawal by transfer credit to the L.F. a/c of respective Urban Local Bodies.
