Subject: **Allotment of fund in favour of Urban Local Bodies to undertake the immediate restoration work of roads and other important civic services in connection with the recent earthquake under Development of Municipal Areas Scheme.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.1,25,00,000/- (Rupees one crore twenty five lakh) only in favour of the Urban Local Bodies as detailed in the enclosed statement as grants to undertake the immediate restoration work of roads and other important civic services in connection with the recent earthquake in the month of September, 2011 within the Darjeeling district under Development of Municipal Areas scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The Utilisation Certificates in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I are to be furnished by the concerned Urban Local Bodies to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department and the concerned District Magistrate.

4. The fund will be utilised strictly for the purpose for which it is sanctioned and strictly adhering to Govt. circular issued time to time on financial propriety.

5.1. The schemes shall be implemented only after vetting of plan and estimates of each schemes by the appropriate technical authority corresponding to vetting limits.

5.2. A list of the schemes undertaken indicating the names, locations, estimates and expenditure along with vetted estimates invariably be furnished to this Department.

6. The amount is debit to the heads of account under Demand No. 39/MA in the current year's vote-on-account budget as detailed below :
