**Sub : Allotment of Fixed Grant to the Municipal Corporation and other Urban Local Bodies towards salaries of their employees (Excluding Kolkata Municipal Corporation & Howrah Municipal Corporation) for the month of April, 2009 (on Ad-hoc basis).**

In continuation of Government Order No.373G/MA/N/C-2/1G-1/2008 dt.12.03.2009 the undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs.13,65,31,588/- (Rupees Thirteen crore sixty five lakh thirty one thousand five hundred and eighty eight) only on the ad-hoc basis to the Urban Local Bodies as stated against each in the enclosed statement the grant towards salaries of their employees for the month of April, 2009.

2. The District Magistrate concerned is hereby authorised to draw the amount sanctioned herein above and disburse the same to the concerned Urban Local Bodies by transfer credit through the Local Fund Account of the concerned Urban Local Bodies only, For Dankuni Municipality in Hooghly, The Chairman of the Board of Administrator shall act as the D.D.O.
3. Any over payment or under payment in this regard against Revised Basic Pay as per ROPA-2009 will be adjusted from the grants to be released for this purpose later.
4. The charge is debitable to the head, "2217-Urban Development-05-Other Development Scheme-191-Assistance to Municipal Corporation-NP-Non-Plan-019-Fixed Grants to the Municipal Corporation & Other Local Bodies towards salaries of their employees-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA in the current year's budget 2009-2010.
5. The Utilisation Certificate in respect of the grant to be drawn by the Local Body should be submitted in the prescribed form directed to the Principal Accountant General (A&E), West Bengal with a copy to the undersigned, as soon as the amount is drawn and utilised.
6. Utilisation Certificate upto March, 2009 shall be furnished by the concerned Urban Local Bodies failing which further allotment will remain withheld.
7. The Principal Accountant General(A&E), West Bengal/Treasury Officer and other concerned are being informed.
8. This order issues in exercise of the power delegated under Finance Department Memo No.2500-FB dated 31.03.2009.


