**Sub: Payment of grant on account of Entertainment Tax Grant in the
Howrah Municipal Corporation during the year 2007-2008.
(5th instalment)- Revalidation of the Govt. Order.**

The undersigned is directed to state that an amount of Rs. 1,15,14,000/- (Rupees One crore Fifteen lakh fourteen thousand) only sanctioned in favour of Howrah Municipal Corporation on account of Entertainment Tax Grant (5th instalment) during the year 2007-2008, sanctioned in G.O. No. 477G/MA/N/C-2/1G-6/2007 dated 28.03.2008 could not be drawn and utilized in the financial year 2007-2008.

2. In partial modification of G.O.No.477G/MA/N/C-2/1G-6/2007 dated 28.03./2008, the undersigned is further directed by order of the Governor to say that the Governor is pleased to sanction and release afresh the payment of a sum of Rs.1,15,14,000/- (Rupees One crore Fifteen lakh fourteen thousand) only as Entertainment Tax Grant (5th instalment) to the Howrah Municipal Corporation for the year 2007-2008 from this financial year's budget i.e. 2008-2009.


3. The fund sanctioned above will be drawn by the Commissioner, Howrah Municipal Corporation in T.R. Form No 31 after it is duly countersigned by District Magistrate, Howrah.

4. The charge will be debitible to the head, "3604-Compensation & Assignment to the Local Bodies and Panchayati Raj Institution-00-103-Entertainment Tax-NP-Non-plan-005-Grants-in-aid to the Municipal Corporation and Urban Local Bodies-31-Grants-in-aid-02-other Grants-V" under Demand No. 39/MA in the current year's budget i.e. 2008-09.

5. The grants-in-aid sanctioned in para-1 above is for general purpose/non salary grant which is released to the Urban Local Bodies for particular purposes of liquidation after reconciliation of outstanding dues of CESC/WBSEB/HUDCO if any on priority basis and for payment against cost of establishment after clearing the dues of aforesaid agencies Utilisation Certificate is to be furnished by the ULBs in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal Volume-1 to Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the grant is drawn and utilised.

6. This order issues with the concurrence of the Finance Department (Vide their U.O. No. 116 Gr-R dated 01.08.2008).

7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.


