Sub : Release on revalidation of fund to Nalhati Municipality initially released under this Deptt. G.O. No.365(19)/MA/P/C-10/3S-46/2005(FS) dt.12.02.08 as the 1st instalment of the 12th F.C.'s Award for 2007-08.

The undersigned is directed to say that a sum of Rs.8,45,500/- (Rupees Eight lakh forty five thousand five hundred) only was sanctioned in favour of Nalhati Municipality as the 1st instalment of 12th F.C. Award for 2007-08, vide this Deptt. G.O. No. 365(19)/MA/P/C-10/3S-46/2005(FS) dt.12.02.08 for implementation of various development works. Out of the amount sanctioned therein, Rs.4,22,800/- was meant to be spent for Solid Waste Management Scheme and Rs.4,22,700/- for Data-base, maintenance of Accounts and other non-SWM schemes. Rs.4,22,800/- meant for the SWM scheme, however, could not be drawn by the Municipality during the last financial year, due to some unavoidable circumstances.

2. The District Magistrate, Birbhum has now approached for re-allotment/revalidation of the lapsed fund from the budget allocation of the current financial year.

3. After careful consideration and in partial modification of this Deptt. G.O. No. 365(19)/MA/P/C-10/3S-46/2005(FS) dt.12.02.08, the undersigned is directed, by order of the Governor to say that the Governor is pleased to revalidate and sanction the said amount of Rs.4,22,800/- (Rupees Four lakh twenty two thousand eight hundred) only in favour of Nalhati Municipality out of the current year's budget allocation under the 12th F.C. Award.

4. The District Magistrate, Birbhum is, hereby, authorised to draw the amount sanctioned in para 3 above in T.R. Form No.31 and disburse the same to the Nalhati Municipality through transfer credit to the Local Fund Account of the Municipality in the Treasury concerned for implementation of the programme.


5. The Municipality will be the executing agency in implementing the programme and will implement the same as per the guidelines for implementation of the programme circulated earlier.

6. The Utilisation Certificate on the lines mentioned in the foregoing paras, will be furnished by the Municipality concerned in terms of Note-2 below S.R. 330A of the Treasury Rules, W.B. Vol-I and Physical and Financial Progress to the appropriate authority in the prescribed format.

7. The charge is debitible under the head of account "2217-Urban Development-80-General-800-Other Expenditure-NP-Non Plan-006-Assistance to Urban Local Bodies as Recommended by the Twelfth Finance Commission [MA]-31-Grants-in-aid-02-other grants-V" under Demand No.39/MA during the current financial year.

7. This order issues with the concurrence of the Finance Department vide their U.O. No. Group 'N' 1126 dated 10.092008.
