ORDER

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord sanction and release a sum of Rs. 10,01,99,000/- (Rupees ten crore one lakh ninety nine thousand) only to Kolkata Municipal Corporation under Direct Procedure for implementation of Kolkata Environmental Improvement Investment Programme (KEIIP)-Project-1 (Asian Development Bank assisted programme under Loan No. 3053-IND).

2. The amount has been released in favour of the State Government being the Loan component of Additional Central Assistance for the aforesaid project payable in the year 2014-2015 and 2015-2016 under Direct Procedure on back to back basis as 100% loan by the Department of Expenditure, Plan Finance-I Division, Ministry of Finance, Government of India vide their following sanction letter:-



3. The Loan amount has to be adjusted by Contra Credit to the Head of Account "6004-02-101-005-26". The adjustment shall be made by the A.G. (A&E), West Bengal in due course. No fund will be drawn from Treasury/P&A.O. against this release.

The above adjustment is to be made in the current year's budget for the year 2015-2016 from the Head of Account "6217-Loans for Urban Development-60-Other Development Schemes-191-Loans to Local Bodies, Municipal Corporation, etc.-SP-State Plan (annual Plan & XII th Plan)-017-Loans to Kolkata Municipal Corporation for Kolkata Environmental Improvement Investment Programme (KEIIP)(ADB)[EAP][MA]-55-Loans and Advances" (code: 6217-60-191-SP-017-V-55) under Demand No. 39 and Departmental Code MA.

5. The terms and conditions of loan shall be guided by the Onlending Agreement executed between the State Government and Kolkata Municipal Corporation on 30.05.2014.


