Sub: Release of fund by revalidation to Murshidabad Municipality released under this Department Govt. Order No.430/MA/P/C-10/1G-26/2005 Pt.(FS) dt.11.03.2008 under Basic Minimum Service during 2007-08.

1. The undersigned is directed to say that a sum of Rs. 40,00,000/- (Rupees Forty lakh) only as grant was sanctioned in favour of Murshidabad Municipality under this Department Govt. Order No. 430/MA/P/C-10/1G-26/2005 Pt.(FS) dated 11.03.2008 for improvement of Slum Infrastructure and Housing under Basic Minimum Service Programme during the year 2007-08. However, the said fund could not be drawn by the concerned Municipality owing to some unavoidable circumstances.
2. The concerned Municipality has now prayed for re-allotment/ re-validation of the said lapsed fund from the budget allocation of the current financial year.
3. However, the head of A/c. " 2217-05-191-SP-043-31-02" under which the amount of Rs. 40,00,000/- (Rupees Forty lakh) only was sanctioned in favour of Murshidabad Municipality under this Department Govt. Order No. 430/MA/P/C-10/1G-26/2005 Pt.(FS) dt.11.03.2008 during the last financial year (2007-08), has now been assigned to the Municipal Corporations from the current financial year (2008-09).
4. After careful consideration of the matter and in partial modification of this Department Govt. Order No. 430/MA/P/C-10/1G-26/2005 Pt.(FS) dated 11.03.2008, the undersigned is directed, by order of the Governor, to say that the governor has been pleased to revalidate and sanction the said amount of Rs. 40,00,000/- (Rupees Forty lakh) only in favour of Murshidabad Municipality out of the budget allocation under the head of Account assigned to the Municipalities of the State for improvement of Slum infrastructure and housing within the Municipal areas of the Municipality under Basic Minimum Services Programme.
5. The District Magistrate, Murshidabad is hereby authorised to draw the amount sanctioned in para 4 above in T.R. Form No.31 and release the same to concerned Municipality by way of transfer credit to Local Fund Account with the Treasury concerned.
6. The utilisation certificate of the fund released is to be furnished by the Municipality in terms of SR 330A of the Treasury Rules, W.B., Vol-I immediately after the same is utilised.
7. The charge is debitible to the head of A/c. "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities/Municipal Councils-SP-State Plan (Annual plan and 11th plan)-007-Grants to Municipalities for ongoing scheme of erstwhile BMS Programme-V-Voted-31-Grants-in-aid-02-Other grants " in the current year's Budget provision under Demand No. 39/MA.
