Sub : Release of fund by way of revalidation to Murshidabad & Rampurhat Municipalities released under this Department G.O.No.447/MA/C-10/3S-43/2005(FS) dated 14.03.2008 under "Employment Generation in Urban Areas Scheme" during 2007-08. .

The undersigned is directed to say that a sum of Rs.16,71,210/- (Rupees sixteen lakh seventy one thousand two hundred and ten) only which was sanctioned in favour of Urban Local Bodies as detailed in the enclosed statement under Employment Generation in Urban Areas scheme during 2007-08, vide this department G.O.No.447/MA/C-10/3S-43/05(FS) dated 14.03.08, could not be drawn by the concerned Urban Local Bodies due to some unavoidable circumstances.

2. The Urban Local Bodies have now prayed for re-allotment/revalidation of the lapsed fund from the budget allocation of current financial year.

3. After careful consideration and in partial modification of this Department G.O.No.447/MA/C-10/3S-43/05(FS) dated 14.03.08 the undersigned is directed by order of the Governor to say that the Governor is pleased to revalidate and sanction the said amount of Rs.16,71,210/- (Rupees sixteen lakh seventy one thousand two hundred and ten) only to the Urban Local Bodies as detailed in the enclosed Statement for implementation of the above mentioned scheme.

4. The District Magistrates concerned are authorised to draw the amount sanctioned in para-3 above in T.R. Form No.31 and disburse the same to the concerned urban local bodies by transfer credit to their local fund account with the treasuries concerned for implementation of the programme in accordance with the guidelines issued by the Government for the purpose.

5. The charge is debit to the Heads of Accounts under Demand No.39/MA in the current year's budget, as detailed below :-

8. A list of schemes undertaken showing its name, location, estimate and expenditure incurred should invariably be furnished to facilitate release of further funds under this programme in future
