The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs. 1,73,50,000/- (Rupees one crore seventy three lakh fifty thousand) only to the Urban Local Bodies as detailed in the enclosed statement for construction / extension / renovation of their Office Buildings, as the case may be as per representations received.

2. The District Magistrates concerned are authorized to draw the amount sanctioned herein in respect of the local body under his jurisdiction and to disburse the same to the concerned local bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned. The urban local bodies will execute the scheme after vetting the plans and estimates by the Municipal Engineering Directorate.
3. The District Magistrates will please obtain Utilization Certificate in respect of the amount sanctioned herein in terms of Note-2 below S.R.330 of the Treasury Rules, West Bengal, Volume-I, from the concerned local bodies and to submit a copy of the same direct to the Accountant General, West Bengal and also a copy to this department after satisfying himself about the authenticity, accuracy of the same and compliance of the conditions of this order, within the current financial year.
4. The fact of drawal / non-drawal of the grant by the concerned local bodies, as may happen, should be reported to this Department immediately. Further fund, if at all, can be released only on receipt of utilization certificate of earlier and this allotment from the urban local bodies.
5. The charge is debitable to the head, "2217-Urban Development-80-General-800-Other Expenditure-SP-State Plan(Annual Plan & Eleventh Plan)-002-Construction of Municipal Buildings-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No. 39/MA in the current year's Budget.
6. This order issues in exercise of the powers delegated under Finance Department Memo No.850-F.B. dated 31.07.2008.
7. The Accountant General (A&E), West Bengal and others concerned are being informed.
