I am directed by order of the Governor to say that the Governor has been pleased to accord sanction and release to the payment of Rs. 1,41,97,000/- (Rupees One crore forty one lakhs ninety seven thousand) only to the Kolkata Municipal Corporation under "Reimbursement Procedure" for implementation of the Kolkata Environmental Improvement Project (Asian Development Bank assisted programme under Loan No. 2293-IND).

2. The said amount has been released in favour of the State Government as Additional Central Assistance as 100% loan on Back to Back basis during the year 2012-2013 for the said externally aided project in terms of Department of Expenditure, Ministry of Finance, Plan Finance-I Division, Government of India vide their sanction letter no. F. No. 53(2)/PFI/2012-273 dated 20.06.2012 and F. No. 53(2)/PFI/2012-236 dated 15.06.2012.
