In continuation of G.O.No.177G/MA/N/C-2/1G-1/2009 dated 14.9.09 and G.O.No.179G/MA/N/C-2/1G1/2009 dt.14.09.09 the undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release a sum of Rs.64,60,288/- (Rupees Sixty four lakhs sixty thousand two hundred and eighty eight) only as grant for payment of fixed grant towards salaries to the employees of Bongaon/Kulti/English Bazar Municipality for the month of October, 2009 subject to the following conditions :-

2. Any over payment or under payment in this regard against Revised Basic pay as per ROPA-2009 will be adjusted from the grants to be released for this purpose later.

3. The grants-in-aid sanctioned herein above will be drawn by the concerned District Magistrate and he will deposit the same in his P.L. A/c and disburse as salaries to the existing regular employees of the Urban Local Bodies as against sanctioned strength from his and under this jurisdiction.

4. The charge is debitable to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-Non-Plan-019-Fixed Grants to the Municipal Corporation and other Local Bodies, towards salaries of other employees-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA" in the current year's i.e. 2009-2010. Vote-on-Account provision.

5. Utilisation Certificate in respect of the grants to be drawn by the concerned Urban Local Bodies should be furnished in the prescribed form in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I direct to the Principal Accountant General(A&E), West Bengal with a copy to the undersigned, as soon as the amount is drawn and utilised, submission of Utilisation Certificate upto September, 2009 will be required for further grants in this respect.

6. The Principal Accountant General(A&E), West Bengal and other concerned are being informed.
