**Sub : Fund for running SSP Centres during 2009-2010.**

In partial modification of G.O.No.98G/MA/N/C-2/1G-3/2009 dated 30.07.2009, the undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs.2,98,50,000/- for arrear payment for the period 01.04.2008 to 31.03.2009 and Rs.6,50,67,000/- for payment of honorarium upto July'09 to Siksha Sahayikas & Academic Supervisors of Sishu Siksha Kendras totalling to an amount of Rs.9,49,17,000/- (Rupees Nine crore fortynine lakh seventeen thousand) only to the Director of Local Bodies, West Bengal for smooth running of Sishu Siksha Kendras within the Urban Local Bodies during 2009-2010.

2. The amount sanctioned in para-1 above is to be monitored and sub-allotted from the level of Director of Local Bodies, West Bengal in favour of the Urban Local Bodies and the District Magistrate of the concerned district will act as the D.D.O. for drawal by transfer credit to the L.F. Account of respective Urban Local Bodies.

3. The charge is debitable to the head, "3604-Compensation and Assignment to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to Municipal Corporations & Other Urban Local Bodies-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the current year's budget i.e. 2009-2010.

4. Utilisation Certificate is to be furnished by the Director of Local Bodies, West Bengal in terms of Note-2 below SR 330A of the West Bengal Treasury Rules, Volume-I directly to P.A.G.(A&E), West Bengal with a copy to this Department.
