Subject: - Sanction of grants to the State Election Commission, West Bengal, for the use of West Bengal State Election Commission and for sub-allotment to the DMEOs and D.Ms in connection with the Municipal General Election held in the month of July, 2011 and outstanding liabilities in connection with the Municipal general elections held in 2010

Sir,

I am directed by order of the Governor to say that the Governor is pleased to sanction a sum of Rs. 30.00 lakh (Rupees Thirty lakh) only and to allot the same to the Secretary, State Election Commission, West Bengal for the use of West Bengal State Election Commission and for sub-allotment to the DMEOs and DMs in connection with the Municipal Election held in the month of July, 2011 and outstanding liabilities in connection with the Municipal General Elections held in 2010.

2. The concerned District Municipal Election Officers will act as Drawing and Disbursing Officer for this purpose. The Accounts Officer, State Election Commission West Bengal is hereby authorized to draw necessary bill for this grants-in-aid bill form (T.R. Form No. 48) of West Bengal Treasury Rules, Volume-II from the Kolkata Pay and Accounts Office.

3. The Secretary, West Bengal State Election Commission is also hereby authorized to allow the District Magistrates to make appropriate sub-allotment in favour of the Sub divisional Officers concerned for drawing and disbursement of the grant as and when considered necessary. Necessary bill for this grant will be drawn in grants-in-aid bill form (T.R. Form No. 48) of West Bengal Treasury Rules, Volume-II.

4. The District Magistrates shall submit the Utilisation Certificates in respect of the aforesaid grant in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I to the Principal Accountant General (A&E), West Bengal with a copy of West Bengal State Election Commission and to this Department in due course. On receipt of the Utilisation Certificates for the amount sanctioned in this connection, further allotment will be considered by the West Bengal State Election Commission.

5. The charge will proceed against the head, "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities/Municipal Councils.-Non-Plan-003-Grants to Municipalities" to meet in connection with their election-V-31-Grants-in-aid-GENERAL-02-Other Grants" for the year 2011-2012 out of vote-on-account Budget provision under Demand No. 39 with the Departmental Code "MA".

6. This order issues in exercise of the power delegated under Finance Department Memo No. 700-FB dated 31.03.2011.

7. The Principal Accountant General (A&E), West Bengal and the Kolkata Pay and Accounts Office are being informed.
