**Sub :** **Fund in favour of Dankuni Municipality, newly created in the District of Hooghly, to meet up the start-up expenses – release of fund from the Fixed Grant of 2006-2007.**

The undersigned is directed to state that Dankuni in the District of Hooghly has been constituted a municipal area by notification bearing No. 732/MA/O/C-4/1M-11/96 dated 27.10.2008 and with effect from 1<sup>st</sup> day of November, 2008.

2. The undersigned is, therefore, directed by order of the Governor to say that the Governor has been pleased to sanction and release for payment of a sum of Rs. 10,00,000/- (Rupees ten lakh) only in favour of Dankuni Municipality as the start-up expenses of the newly created Urban Local Bodies through District Magistrate, Hooghly.

3. The Director, S.U.D.A. is hereby directed to pay a sum of Rs. 10,00,000/- only to the District Magistrate, Hooghly for the purpose indicated at para-2 by issuing L.F. A/c payee cheque in favour of the District Magistrate, Hooghly out of the fund placed in S.U.D.A.'s L.F. A/c under G.O. No. 405G/MA/N/C-2/1G-3/2006 dated 30.3.2007 drawn under the head '3604-00-200-NP-Non-Plan-034-Fixed Grant to the Municipal Corporation & other ULBs-31-Grants-in-aid-02-other Grants-V' under demand No. 39 during the financial year 2006-2007.

4. The Utilisation Certificate in terms of Note 2 below Rule 330A of WBTR Vol. 1, is to be furnished by Dankuni Municipality directly to the Principal Accountant General(A&E), West Bengal with a copy to this Department.
