Sir,

I am directed by order of the Governor to say that the Governor has been pleased to accord sanction and release to the payment of Rs. 4,60,67,000/- (Rupees Four crore sixty lakhs sixty seven thousand) only to the Kolkata Municipal Corporation under "Reimbursement Procedure" for implementation of the Kolkata Environmental Improvement Project (Asian Development Bank assisted programme under Loan No. 2293-IND).

2. The said amount has been released in favour of the State Government as Additional Central Assistance as 100% loan on Back to Back basis during the year 2010-2011 for the said externally aided project in terms of Department of Expenditure, Ministry of Finance, Plan Finance-I Division, Government of India vide their sanction letter no. F. No. 53(2)/PFI/2010-435 dated 16.08.2010, F. No. 53(2)/PFI/2010-483 dated 27.08.2010, F. No. 53(2)/PFI/2010-539 dated 09.09.2010, F. No. 53(2)/PFI/2010-1141 dated 27.01.2011, F. No. 53(2)/PFI/2010-1258 dated 23.02.2011, F. No. 53(2)/PFI/2010-1336 dated 10.03.2011 and F. No. 53(2)/PFI/2010-1557 dated 31.03.2010.

3. The Municipal Commissioner, Kolkata Municipal Corporation is hereby authorized to draw the amount mentioned in para 1 above in TR Form No. 31 from the Kolkata Pay & Accounts Office after it is duly countersigned by the Sanctioning Authority.


