Sub : Grant of Entertainment Tax (2008-09) in favour of
Kolkata Municipal Corporation (3rd instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction the payment to the D.D.O., Kolkata Municipal Corporation a sum of Rs.4,36,00,000/- (Rupees Four crore thirty six lakh) only as the grants-in-aid towards Entertainment Tax Grant (3rd instalment) during 2008-2009 for particular purposes of liquidation after reconciliation of outstanding dues of CESC/WBSEB/HUDCO etc., if any, on priority basis and for payment against cost of establishment after clearing the dues of aforesaid agencies.

2. The grant-in-aid as sanctioned above will be drawn by the Controller of Municipal Finance & Accounts, Kolkata Municipal Corporation in T.R. Form No.31, after it is duly countersigned by the sanctioning authority.

3. The charge is debitable to the Head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj Institution-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporation and other Local Bodies-31-Grants-in-aid-02-Other Grants-V" (MA), under Demand No.39/MA in the budget of 2008-2009.

4. The Utilisation Certificate will be furnished by the Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume - I to the Principal Accountant General(A&E), West Bengal with a copy to this Department.

5. This order issues in exercise of the power delegated under Finance Department Memo No.850-FB dated 31.07.2008.

6. The Principal Accountant General(A&E), West Bengal and other concerned are being informed.
