**Sub : Release of Entertainment Tax to Howrah Municipal
Corporation during 2008-09 (3rd instalment).**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of Rs.96,00,000/- (Rupees Ninety six lakh) only to the Howrah Municipal Corporation as grant on account of Entertainment Tax during the year 2008-2009 (3rd instalment).

2. The fund sanctioned above will be drawn by the Commissioner, Howrah Municipal Corporation in T.R. Form No.31, after it is duly countersigned by District Magistrate, Howrah.
3. The charge is debitable to the Head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj Institution-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporation and other Local Bodies-31-Grants-in-aid-02-Other Grants-V" (MA), under Demand No.39/MA in the current year's budget i.e. 2008-2009.
4. The grants-in-aid sanctioned in para 1 above is for general purpose/Non-Salary grant which is released to the Urban Local Body for particular purposes of liquidation after reconciliation of out standing dues of CESC/WBSEB/HUDCO, if any, on priority basis and for payment against cost of establishment after clearing the dues of aforesaid agencies.
5. The Corporation should furnish Utilisation Certificate to the Principal Accountant General(A&E), West Bengal in prescribed form as soon as the grant is drawn and utilised.
6. This order issues in exercise of the power delegated under Finance Deptt's Memo No.850-FB dated 31.07.2008.
7. The Principal Accountant General(A&E), West Bengal and other concerned are being informed.
