**Sub: Payment of Grant on account of Entertainment Tax to Urban Local Bodies during the year 2011-2012 (3<sup>rd</sup> instalment), including arrear if any.**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a sum of Rs.10,29,30,000/- (Rupees ten crore twenty-nine lakh thirty thousand) only as the grant on account of Entertainment Tax Grant (3<sup>rd</sup> instalment) to the Urban Local Bodies as per enclosed statement for the year 2011-2012.

2. The fund sanctioned above will be drawn by the concerned District Magistrate who will disburse the amounts to the Urban Local Bodies in his jurisdiction by transfer credit through L.F.A./C of the concerned Urban Local Bodies and will impress upon the Urban Local Bodies to clear the dues to WBSEDCL/CESC on priority basis.

3. The charge is debitable to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-103-Entertainment Tax-NP-Non-Plan-005-Grants-in-aid to Municipal Corporations and other Urban Local Bodies - 31-Grants-in-Aid-GENERAL-02-Other Grants-V" (MA) under Demand No. 39/MA in the current year's budget i.e. 2011-2012.

4. The Grants-in-aid being sanctioned in para-1 above is for general purpose /Non-Salary Grant which is released to the Urban Local Bodies for payment against cost of Establishment and or for liquidation after reconciliation of outstanding dues of CESC /WBSEDCL etc. on priority basis.

5. The Utilisation Certificate is to be furnished by the Urban Local Bodies in terms of Note -2 below SR 330A of the Treasury Rules, West Bengal, Volume-I to the Principal Accountant General (A&E), West Bengal with a copy to this Department.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 1920- FB dated 22.09.2011.

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
