Subject: Release of fund for rollout of Software Component of Municipal e-Governance in 41 non-KMA Urban Local Bodies(Phase-I) under Development of Municipal Areas Scheme.

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.1,74,83,500/-(Rupees one crore seventy four lakh eighty three thousand five hundred) only in favour of the Change Management Unit(CMU) for rollout of Software Component of Municipal e-Governance in 41 non-KMA Urban Local Bodies(Phase-I) as per the proposal contained in the CMU's U.O. No.CMU-15/2002(Pt-V)/71 dated 16.11.2011 under Development of Municipal Areas Scheme.

2. An amount of Rs.1,74,83,500/-(Rupees one crore seventy four lakh eighty three thousand five hundred) only is allotted herewith to meet the expenditure mentioned at Para 1.
