In continuation of Memo No.376G/MA/N/C-2/1G-26/2007 dated 19.02.2008, the undersigned is directed by order of the Governor to say that the Governor has been pleased to sanction & release for further payment of a sum of Rs.10,00,000/- (Rupees Ten lakh) only in favour of Garulia Municipality in the District of North 24 Parganas during 2008-09.

2. The fund is a general purpose grant (non-salary items) which will be used by the Municipality for payment of arrear electricity bill of C.E.S.C. and will be adjusted against the future grant to the Municipality in due course.

The Director, S.U.D.A. is hereby directed to pay a sum of Rs.10,00,000/- (Rupees Ten lakh) only to Chairman, Garulia Municipality by issuing Account payee Cheque in favour of the Chairman, Garulia Municipality out of the fund placed in SUDA's Local Fund Account under G.O. No. 477G/MA/N/C-2/1G-22/2005 dt.30.3.2006 drawn under the head, "3604-00-200-NP-Non-Plan-034-Fixed Grants to the Municipal Corporation & other Urban Local Bodies (MA)-31-Grants-in-aid-02-other Grants-V" under demand No. 39 during the financial year 2005 - 2006.

4. The Utilisation Certificate in terms of Note 2 below Rule 330A of WBTR Vo. 1 is to be furnished by Garulia Municipality direct to the Principal Accountant General (A&E), W.B. with a copy to this Department.
