The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release of a sum of Rs.22,98,341/- (Rupees Twenty two lakh ninety eight thousand three hundred and forty one) only to the Kulti, Bongaon and English Bazar Municipality as grant for payment of Dearness Allowance @ 41% for the month of December,2008 as per revised staff statistics.

The Grants-in-aid sanctioned herein above will be drawn by the District Magistrate, Burdwan/North 24-Parganas/Malda who will deposit the same in his P.L.A/c. and will then disburse as Dearness Allowance to the existing regular employees of the Kulti/Bongaon/English Bazar Municipality against sanctioned strength from his end under his jurisdiction.

The charge is debitable to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-020-Dearness Concession to the Employees of Municipal Corporation and other Urban Local Bodies in K.M.D.A. & Non-K.M.D.A. Areas-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA in the current year's budget (2008-2009).

4. The Utilisation Certificate in respect of the grants to be drawn by the Kulti/Bongaon/English Bazar Municipality should be furnished in the prescribed form direct to the Principal Accountant General (A&E), West Bengal, with a copy to this Department as soon as the amount is drawn and utilised. Submission of Utilisation Certificate up to Novembber,2008 will be required to release further grants in this regard.
