Sub : Payment of Grant for maintenance of Civic Services by the Bidhannagar  
Municipality during 2008-2009.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction payment of a grant of Rs.37,61,700/- (Rupees Thirty seven lakh sixty one thousand and seven hundred) only to the Bidhannagar Municipality, for maintenance of Civic Services for 2008-2009.

2. The allotment of a sum of Rs.37,61,700/- (Rupees Thirty seven lakh sixty one thousand and seven hundred) only sanctioned herein, is placed at the disposal of the District Magistrate, North 24-Parganas who will draw & disburse the same to the Bidhannagar Municipality.

3. The Charge will be debitable to the head, "2217-Urban Development-05-Other Urban Development Scheme-191-Assistance to Municipal Corporations-NP-Non-Plan-018-Bidhannagar (Salt Lake) Notified Area Authority (Bidhannagar Municipality)-31-Grants-in-Aid-02 Other Grants-V" under Demand No.39(MA) in the current year's budget i.e. 2008-2009.

4. The fact of drawal or non-drawal of the grant during the current financial year, as may happen, should be reported to this Department in good time before the close of the financial year.

5. The Utilisation Certificate in respect of the grant to be drawn by the Municipal Authority should be submitted in the prescribed form directly to the Principal Accountant General, West Bengal, with a copy to the Director of Local Bodies, West Bengal as soon as the amount is drawn and utilized. The Director of Local Bodies, West Bengal will report to the Department about the position regarding submission of Utilisation Certificate by this Local Body.

6. This order issues in exercise of the powers delegated under Finance Department Memo. No.1818-FB dated 31.12.2008.

7. The Principal Accountant General (A&E), West Bengal/Treasury Officer and other concerned are being informed.
