'Relief-on-Pension' to the Municipal Pensioners during the year 2008-2009.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for the payment of a sum of Rs.1,82,10,516/- (Rupees One crore eighty two lakh ten thousand five hundred and sixteen) only to the Howrah Municipal corporation as grant on ad-hoc basis for payment of 'Relief-on-Pension' on the revised scale of pay to the Pensioners of the Howrah Municipal Corporation as residual amount for 2008-2009 out of their total claim of Rs.3,64,21,032/- for 2008-2009.

2. The grants-in-aid sanctioned herein above will be drawn by the Commissioner of the Howrah Municipal Corporation in T.R. Form No.48 after it is duly countersigned by the District Magistrate, Howrah.

3. The charge is debitible to the head, "2071-Pensions and Other Retirement Benefits-01-Civil-110-Pension to employees of Local Bodies-NP-Non-Plan-001-Provision for payment of pension to employees of Local Bodies-04-Pension/Gratuity-V" under Demand No.18/Finance (Audit) in the current year's budget i.e. 2008-2009.

4. Utilisation Certificate is to be furnished by the Howrah Municipal Corporation in the prescribed form in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal direct to the Principal Accountant General (A&E), West Bengal, with a copy to this Department positively, as soon as the amount is drawn and utilised.

5. This order issues in exercise of the Power delegated under Finance Department Memo No.1818-FB dt.31.12.2008.
