The undersigned is directed by order of the Governor, to say that the Governor is pleased to sanction payment of a sum of Rs.60,08,835/- (Rupees sixty lakh eight thousand eight hundred and thirty five) only to the Urban Local Bodies as detailed in the enclosed statement as grants for Infrastructure Development of Minority Community Areas under Basic Minimum Services Programmes, being the share of Municipal Affairs Department in terms of memo. no.862/MA/C-10/2S-15/2007 Pt dated 13.08.2008 of this Department.

2. The District Magistrates concerned are authorized to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The scheme will be executed by the concerned Urban Local Bodies strictly adhering to the Guideline circulated earlier, bearing the memo. mentioned at para.1, hereinbefore, as well as conforming to the BMS Guideline made available to the ULBs.

4. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Bodies to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department, the concerned District Magistrates as well as the State Urban Development Agency.

5. The charge is debitable to the head of account, "2217-Urban Development-05-Other Urban Development Schemes-192-Assistance to Municipalities / Municipal Councils-SP-State Plan(Annual Plan & Eleventh Plan)-007-Grants to Municipalities for ongoing schemes of erstwhile BMS programmes-V-Voted-31-Grants-in-aid-02-Other Grants" under Demand No. 39/MA in the current year's Budget.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 900-F.B. dated 27.07.2009.

7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.


