The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.85,00,000/- (Rupees eighty five lakh) only to the Urban Local Bodies for construction / extension / renovation of their Office Buildings, as the case may be as per representations received, as detailed in the enclosed statement.

2. The District Magistrates concerned are authorised to draw the amount sanctioned in para 1 above in T.R. Form No.31 and to disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned.
3. The Utilization Certificates in terms of S.R.330A of the Treasury Rules, West Bengal, Volume-I are to be furnished by the concerned Urban Local Bodies to the Principal Accountant General(A & E), West Bengal with copies endorsed to this department and the concerned District Magistrates.
4. The implementation of the scheme mentioned in this order shall be subject to observation of usual formalities. The balance amount of the project cost will be borne by the concerned Urban Local Bodies.
5. The amount is debit to the head of account, "2217-Urban Development-80-General-800-Other Expenditure-SP-State Plan(Annual Plan & Eleventh Plan)-002-Construction of Municipal Buildings-V-Voted-35-Grants for creation of Capital Assets" under Demand No. 39/MA in the current year's Budget.
6. This order issues in exercise of the powers delegated under Finance Department Memo. No.2450-F.B. dated 30.12.2011 and with the concurrence of the Finance Department vide their U.O. No.Gr'N'0673 dated 02.08.2011.
7. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.
