Sub: **Release of fund for implementation of State Schemes of "Construction/Re-development of Housing of the Urban Poor" during 2011-12**

The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs. 39,92,50,000 (Rupees Thirty Nine crore ninety two lakh fifty thousand) only being the 50% of the proposal contained in the SUDA's letter No. SUDA-55/2010/957 dated 26.08.2011 for implementation of State Schemes of "Construction/Re-development of Housing of the Urban Poor" in the Urban Local Bodies of the State during 2011-12.

2. A sum of Rs. 39,92,50,000 (Rupees Thirty Nine crore ninety two lakh fifty thousand) only is allotted herewith to meet the expenditure mentioned above.

3. The grants-in-aid sanctioned above will be drawn by the Director, State Urban Development Agency in T.R. Form No. 31 after it is duly counter-signed by the sanctioning authority and will be deposited in the Local Fund Account of the State Urban Development Agency by way of transfer credit.


4. The amount so deposited should be disbursed to the Urban Local Bodies on the basis of the principle adopted in this Department earlier as per guidelines and the operational directives and also in terms of the executive directions that may be issued from time to time.

5. The amount is debit to the heads of Accounts detailed below from the Budget provision of the current financial year under Demand No. 39/MA.
