The undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.1,50,00,000/-(Rupees one crore fifty lakh) only in favour of Bidhannagar Municipality for implementation of the various schemes mentioned in the enclosed statement under Development of Municipal Areas scheme.

2. The District Magistrate concerned is authorised to draw the amount sanctioned in para 1 above in T.R. Form No. 31 and disburse the same to the concerned Urban Local Body by transfer credit to its Local Fund Account with the Treasury concerned for the purpose mentioned above.

3. The Utilisation Certificate in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I is to be furnished by the concerned Urban Local Body to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department and the concerned District Magistrate.

4. The Urban Local Body will execute the schemes only after submission of vetted plans and estimates by the appropriate technical authority to this Department.
