Sub : Payment of Grants to Kolkata Municipal Corporations in lieu of taxes realised on trades, professions and callings during 2008-2009 (2nd instalment).

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment a sum of Rs.2,19,20,000/- (Rupees Two Crore nineteen lakh twenty thousand) only to the D.D.O., Kolkata Municipal Corporation as grant in lieu of taxes realised on trades, professions and callings to the Kolkata Municipal Corporation for the year 2008-09 (2nd instalment).

2. The fund sanctioned above will be drawn by the Controller of Municipal Finance & Accounts, Kolkata Municipal Corporation in T.R. Form No.31, after it is duly countersigned by the sanctioning authority and will deposit by transfer credit to the Local Fund Account of Kolkata Municipal Corporation under the head "8448-00-102-001-Deposit to Local Fund A/c" of Kolkata Municipal Corporation.

3. The charge is debitable to the Head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation and Assignments-NP-Non-Plan-021-Grants-in-aid to Kolkata Municipal Corporation in lieu of taxes realised on trades, professions and callings-31-Grants-in-aid-02-Other grants-V" under Demand No.39/MA in the current year's budget i.e. 2008-09.

4. The Grants-in-aid sanctioned in para 1 above is for general-purpose grant, which is released to the Urban Local Bodies for payment of non-plan maintenance work like repair of roads.

5. Utilisation Certificate is to be furnished by the Kolkata Municipal Corporation in terms of Note-2 below S.R. 330A of the Treasury Rules, West Bengal, to the Principal Accountant General(A&E), West Bengal.

6. This order issues in exercise of the powers delegated under Finance Department Memo.No.1818-FB dated 31.12.08.

7. The Principal Accountant General (A&E), West Bengal and other concerned are being informed.
