Subject: **Release of fund for setting of Charge Centre in the Urban Local Bodies for Socio-Economic Caste Census, 2011 under Development of Municipal Areas scheme**

In cancellation of this Department earlier G.O. No.269/MA/P/C-10/3S-15/2011 Pt-I(FS) dated 03.01.2012, the undersigned is directed by order of the Governor to say that the Governor is pleased to accord sanction to the payment of a sum of Rs.93,50,000/- (Rupees ninety three lakh fifty thousand) only in favour of Urban Local Bodies as detailed in the enclosed statement, being the part contribution of this Department, as per the proposal contained in the SUDA's proposal bearing No.114/2011/1529 dated 01.12.2011 for "setting of Charge Centre in the Urban Local Bodies for Socio-Economic Caste Census, 2011" under Development of Municipal Areas scheme.

2. The District Magistrates concerned are authorised to draw the amount sanctioned in para 1 above in T.R .Form No. 31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their Local Fund Accounts with the Treasuries concerned for the purpose mentioned above.

3. The implementation of the scheme mentioned in this order shall be subject to observation of usual formalities and while making the necessary purchase, the Urban Local Bodies shall give preference to procure the computers and printers from reputed company for authenticity and longevity of the product.

4. The Utilisation Certificates in terms of S.R. 330A of the Treasury Rules, West Bengal, Volume-I are to be furnished by the concerned Urban Local Bodies to the Principal Accountant General (A&E), West Bengal with copies endorsed to this Department and the concerned District Magistrates.


