**Sub : Payment of Grants to the Howrah Municipal Corporation in lieu of taxes
realized on trades, professions and callings during 2008-2009 (2nd instalment).**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment of a sum of Rs.40,00,000/- (Rupees Forty lakh) only as grant in lieu of taxes realised on trades, professions and callings to the Howrah Municipal Corporation for the year 2008-2009 (2nd instalment).

2. The fund sanctioned above will be drawn by the commissioner, Howrah Municipal Corporation T.R. Form No.48, after it is duly countersigned by the District Magistrate, Howrah.

3. The charge is debitable to the head, "3604-Compensation & Assignment of Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation and Assignments-NP-Non-Plan-022-Grants-in-aid to Howrah Municipal Corporation in lieu of taxes realised on trades, professions and callings-31-Grants-in-aid-02-Other Grants-V" under Demand No.39/MA in the current year's budget i.e.2008-2009.

4. The Grants-in-aid sanctioned in para 1 above is for general-purpose grant, which is released to the Urban Local Bodies for payment of non-plan maintenance work like repair of roads etc.

5. Utilisation Certificate is to be furnished by the Howrah Municipal Corporation in terms of Note-2 below S.R.330A of the Treasury Rules, West Bengal, to the Principal Accountant General (A&E), West Bengal.

6. This order issues in exercise of the powers delegated under Finance Department memo No.1818 - FB dated 31.07.2008.

7. The Principal Accountant General (A & E), West Bengal and other concerned are being informed.
